14. EX. FIRE PROTECTION PIPING & SPRINKLERS SHOWN ON DRAWINGS ARE FOR GENERAL INFORMATION & REFERENCE ONLY. CONTRACTOR SHALL FIELD VERIFY EX. CONDITIONS INCLUDING ARRANGEMENT, PIPE SIZES, PIPE ROUTING, SPRINKLER LAYOUT, ETC. SEE SPECIFICATIONS."

"5. REMOVE EX. WINDOW AC UNIT & TURN OVER TO OWNER.
6. REMOVE EX. DUCT, GRILLES & DIFFUSERS.
7. EX. FH & ASSOCIATED EXH. DUCTWORK TO REMAIN.
8. REMOVE EX. THERMOSTAT & ASSOCIATED PNEUMATIC TUBING, TYP. REMOVE PNEUMATIC TUBING BACK TO MAIN & CAP.
